  for a period of two weeks (ten business days). The suspension shall be taken within sixty
  (60) days of receipt of the Adjudication Order. Dr. Budz shall notify the Board of the dates
  of the suspension for Board approval;
- 2. Dr. Budz will pay a fine of seven hundred and fifty dollars (\$750); and
- 3. Receive a written reprimand.
