MEETING MINUTES May 12, 2021

Adjudication Hearing: Case#20-20-007 OVMLB vs Ronald Budz, DVM

Beginning at 10:00 a.m., Ms. Arko-Zigler, Assistant Attorney General (AAG) presented the Goldman Hearing case against Dr. Ronald Budz before the board members via TEAMS meeting with a court reporter in attendance. Dr. Budz was notified of the hearing in accordance with ORC 119, but was not present for the hearing. The Board accepted the Exhibits as presented.

Deliberative session – At 10:30 a.m., The Board moved to go into deliberative session to deliberate on File #20-20-007, Ronald Budz, DVM. All of the Board members went into a private conference call.

In the matter of Ronald Budz, VET.3299, Case #20-20-007, Dr. O'Connor moved to issue an Adjudication Order:

- 1. That Dr. Budz's license to practice veterinary medicine in the State of Ohio be indefinitely suspended until compliance with the previous Adjudication Order is completed (Two week suspension and payment of \$750 Fine);
- 2. Dr. Budz will pay a fine of one thousand dollars (\$1000) and;
- 3. Dr. Budz will pay the cost of the hearing.
