May 8, 2007—Special Meeting to develop and review Chapter 4741 of the Ohio Administrative Code

Dr. Small acknowledged the attendance of Theresa Stir, Executive Director, Dr. Attendance Staff, Robert Knapp, OVMA President, Jack Advent, OVMA Director, Michelle Holgreive, Interested parties OVMA Legislative Liaison, Dr. Brenda Johnson, Columbus State Community College and Dr. Kathleen Corcoran, Cuyahoga Community College, representing the RVT educational programs. Dr. Bednarski of the Ohio State University Veterinary Medical program arrived at 10:10 a.m.

The Board began with Rule 4741-1-14 regarding veterinary aide duties. Rules Much of the discussion centered on the proposed change in the rule to allow veterinary aides to draw blood specimens as well as catheterized specimens. The Board has received many comments concerning the proposal. It was determined that the main issue centered on appropriate and consistent training. Dr. Johnson offered to develop a curriculum for an animal aide "phlebotomy" program which might address some concerns. This rule was tabled until the June meeting at which Dr. Johnson hopes to have her proposed training to the Board members.

The Board then discussed the new Limited Licensure rule which was developed as a result of recent enacted legislation. Agreeable language was developed and agreed to by the members and those in attendance. After this discussion, Drs. Johnson, Corcoran and Bednarski left. Jack Advent asked if rules were going to be developed to address the criminal background check legislation recently introduced. After some discussion regarding rules, the Board directed the Executive Director to obtain a copy of the Ohio Board of Nursing's law/rules addressing this issue since they have successfully implemented approximately five years ago. Jack and Michelle left after this discussion.

The Board then reviewed each rule and made appropriate revisions. The Board directed the Executive Director to revise the rules as proposed and bring the revised rules to the June board meeting.

Dr. Burt moved to adjourn the meeting at 4:45 p.m. Dr. Koncal seconded the motion and Adjournment Dr. Small adjourned the meeting until May 9, 2007.
