Board Directives – The directives from the January 2011 board meeting were completed.

Governor Appointments – The Board was provided information on two of the Governor’s Executive Orders (2011-01K and 2011-03K). In the event that an ethics course is not provided to the Boards and Commission, the Board approved that the Executive Director could provide ethics training to the Board members and similar boards and commissions if necessary.

Fiscal – A summary of the Ohio Chamber of Commerce’s report on transforming state government was provided to the Board. An update regarding the Boards and Commission Management Group attempting to introduce legislation to carve out CSA as an independent agency was discussed. There is no report from the State Auditor’s office yet.

Pharmacy – The usage of FatalPlus continues to be prohibited by euthanasia technicians until such time as the Pharmacy Board revises their rules. The Board of Pharmacy and OVMA met with the Board earlier regarding potential legislation which would place the euthanasia technicians under the auspices of the OVMLB. The law regarding the use of FatalPlus can be changed at that time.

Student Loan Progress Reports – The annual report that is required to be submitted to the Governor and General Assembly was provided to the Board members.

Legislative Update – A summary of the status of bills that have been introduced and may impact the Board or veterinary medicine was provided. The Board was informed of a meeting with Rep. Stautberg regarding a 2007 case.
