Adjudication Hearing: Case#21-21-030 OVMLB vs Bharat Khemsara, DVM

In the matter of Bharat Khemsara, VET.4255, Case #21-21-030, Dr. O'Connor moved to issue an Adjudication Order in which Dr. Khelmsara's license to practice veterinary medicine in the State of Ohio has been REVOKED for the following reasons:

- 1. The board found that Dr. Khemsara provided inappropriate medical therapy in face of the differential diagnosis and the poor prognosis which contributed to the demise of the cat
- 2. The Board also took into consideration the multitude of previous violations and disciplinary actions against Dr. Khemsara.
